# Guidelines

- **9-10 am Saturday, Nov. 10th** Check-in at the Pascagoula River Audubon Center if not pre-registered.
  - *Entry forms must be completed at this point.*
  - *If pre-registered, no need to check-in on site.*
- Find your spot in the City of Moss Point to paint.
  - *See attached map for suggestions.*
- **4 p.m.** Return to the Pascagoula River Audubon Center to submit your work/s (up to 3 plein air pieces can be submitted to exhibit).
  - A photograph of your work will be taken at this point, and then you will take your work home with you.
- The following week, all entries will be juried by a panel of judges.
  - The judges will determine: 1st, 2nd and 3rd place winners; and jury the art to be chosen for the Plein Air Art Exhibit.
- If your art is chosen to be displayed in the art exhibit, you will receive a call/email with paperwork to complete.
- **Display-ready artwork** must be returned to the Pascagoula River Audubon Center no later than November 18.
- **The Plein Air Art Exhibit opening reception will be Thursday, November 29 from 5 - 7 p.m. At this event, the winners will be announced.**
- The exhibit will be on display until January 25th, 2019. **All art must be picked up between January 29th and February 2nd.**
